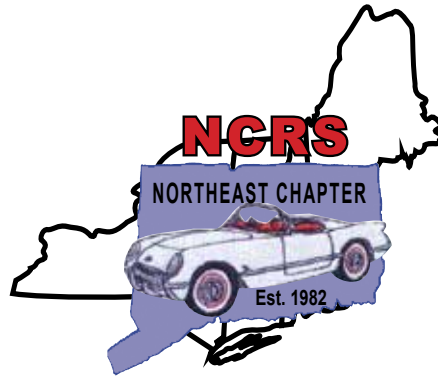

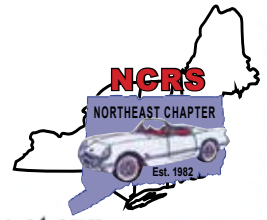


Welcome to Northeast Chapter of the NCRS's annual fall foliage vineyard run. This year we will be going to:


